SEIC Meeting Recap: The SEIC Board and their honored guests held the Fall 2022 SEIC Meeting on Saturday, December 3rd. The group heard updates from the ACA Executive Director, Chair of the Board of Directors, Organizational Partners from the USCG Auxiliary and Boy Scouts of America, the State Director Program, and the ACA DEI Board Committee. The following motions were brought forth from committees and approved during this meeting:

- NOWS Standards Relocation/Reclassification within Level 1 Instructor Criteria
- Redefine IDW/ICE/ICW Candidate Minimums
- Level 2: Essentials of Kayak Touring Document Alignment
- River Kayak Consistency of Kayak-Based Rescue Curriculum
- SEIC Policy Manual Revisions Chapters 2.B, 3.B, and 4.B
- Course Ratio and Maximum Size Revision

The SEIC meeting minutes and further explanation of the impacts to curriculum and/or SEIC policy will be available within the coming weeks. All ACA instructors and trainers should be diligent in utilizing the <u>published criteria and course outlines</u> on the ACA website as the most recent and up-to-date curriculum documents available.

Click that link, and it will take you to a page called "Progress Towards Certification Renewal." That page outlines all the certification renewal requirements, which ones you have met, and which ones you may have not yet met. Cool, right?!
