## Outdoor Alliance "Mining Reform Efforts Heat Up"

Outdoor Alliance has been working hard to reform antiquated mining laws. The Mining Law of 1872 continues to govern mining across most of the U.S., giving mining a pass to the front of the line and often causing direct conflicts with outdoor recreation and conservation priorities. Potential mines currently threaten some of our most-loved outdoor recreation destinations, including the Grand Canyon and the South Fork of the Salmon River.

Some legislation, including the Mining Regulatory Clarity Act, would give away more land to mining companies and allow them to lock out other users and dump mining waste on adjacent public lands, even when they have found no evidence of valuable miners. However, lawmakers are considering legislation that would update antiquated mining laws. The Clean Energy Minerals Reform Act would modernize our mining laws, ensuring that as we transition toward renewable energy, we continue to protect public lands and waters, sacred Indigenous lands, and local communities.

Outdoor Alliance has made it easy to send a message to your lawmakers in support of these needed mining reforms. Personalizing your letter, especially the first few sentences, makes it even more effective.

We are thrilled to announce that the 2024 Slalom Olympic Team Trials will be hosted over two separate weekends in Montgomery, Alabama and Oklahoma City, Oklahoma! The first weekend of racing will take place April 13-14 at Montgomery Whitewater, the newly built, world-class outdoor venue in Montgomery, Alabama! The second weekend of racing will be hosted by RIVERSPORT in Oklahoma, April 26-28.

The results from these two weekends of racing will determine who will fill the Olympic quota spots qualified during the 2023 ICF Canoe Slalom World Championships and the upcoming 2024 COPAC Canoe Slalom Pan American Championships & Olympic Qualifier in Rio de Janeiro, Brazil in March. The Olympic Team, who will be competing at the Paris Olympics this summer will be announced upon the conclusion of racing in Oklahoma City on April 28!

#### 2024 Sprint Olympic Team Trials

The 2024 Sprint Olympic Team Trials will take place in Lake Natoma, March 22-23 in Folsom, California. We are very excited to partner with the Sacramento State Aquatic Center to host this event.

At this event, the best sprint canoe and kayak athletes in the U.S. will compete for the opportunity to fill the Olympic quota spots qualified during the 2023 Sprint Canoe World Championships and the upcoming 2024 ICF Canoe Sprint America's Olympic Qualifier and Pan American Championships to take place in Sarasota, Florida this coming April 23-25. At the conclusion of this weekend of racing, we will name the 2024 Olympic Team who will go on to compete in the 2024 Paris Olympics in August!
