- Assist with an IDW or ICE at your highest level of certification (with the pre-approval of the IT) and complete a review of ACA Policies & Procedures with the IT.

• Co-teach a skills course at your highest level of certification under the supervision of an IT in that discipline and complete a review of ACA Policies & Procedures with the IT.

If browsing the <u>ACA Course Calendar</u> hasn't yet matched with your schedule, <u>reach out to an IT</u> <u>or ITE directly</u> to ask about their availability to help you with one of the update options described above!

You may complete your instructor update at any time during your certification cycle - you do not (and should not) wait until your final year of certification!
