Victory! The EXPLORE Act passed and was signed into law!

Outdoor Alliance and partners have been working on the EXPLORE Act for nearly 10 years and the passage of this bipartisan recreation policy package marks an incredible victory and proof that the voices of paddlers and other outdoor enthusiasts are being heard by our lawmakers.
