

Level 5: Advanced Whitewater Rafting - Oar Skills Assessment

Course Overview

This ACA Assessment Course is designed to evaluate your ability to perform all of the skills listed and demonstrate an appropriate level of paddling knowledge. This assessment course provides the opportunity for you to receive documentation of having achieved this level of paddling ability.

Assessment Course Prerequisites

- Acknowledgment of personal compliance with the <u>ACA Essential Eligibility Criteria</u>
 (<u>EEC)</u>
- Be a current ACA Member

Course Duration

One day (8 hours) or more.

Course Location / Accessible Venues

Sections of rivers rated class III-IV, in rapids where precise maneuvering in current is required to avoid obstacles. A rapid class includes rapids at the lower and upper ends of the difficulty range, designated "-" and "+" respectively.

Course Size

6 Participants : 1 Instructor; with an additional qualified assistant, the ratio can be 12 : 2. The maximum number of participants permitted is 12.

Course Outline

The sequence of assessment should be adjusted to best fit the participant's needs, class location, time allowance, and craft being used. Participants must be able to perform all strokes, maneuvers, rescues, and skills in the appropriate venue. In addition, the participant must demonstrate the appropriate level of knowledge for this level of skill assessment.

Strokes and Maneuvers	Pass? Y/N/DNO
Maneuver a raft 50 yards in a reasonably straight line. Demonstrate both forward and backward	
Stop raft momentum	
Spin the raft and stop at a specific point. Demonstrate both left and right spins. Demonstrate both single and double oar techniques.	
Turn the raft while maintaining momentum	
Catch and maintain position in a relatively small eddy in maximum course venue	
Demonstrate the ability to surf a raft in a hole or on a wave while maintaining proper body position (position of power), explain when surfing is appropriate, including as a maneuver	
Demonstrate efficient catch, power and recovery phases of oar strokes while maintaining proper body position in maximum course venue	
Demonstrate experience and reasonable endurance of rowing on maximum course venue	
Demonstrate ability to obtain, hold, correct, and change raft angle while in a rapid	
Demonstrate consistency in shipping oars properly (not pulling in) and other obstacle management with oars	
Demonstrate the knowledge of and ability to "play boat" including playing with strong eddy lines and boofing a raft

Demonstrate swimming proficiency in maximum course venue

Demonstrate an empty raft flip recovery	
Demonstrate an understanding of loaded raft flip recovery	
Bulldoze raft to shore	
Demonstrate high side commands and technique	
Demonstrate an understanding of how to unpin a raft	
Demonstrate an understanding of appropriate rescue equipment, including safe use of ropes in a whitewater environment	
Have the ability to recognize holes, avoid when necessary, and have knowledge of swim through techniques.	
Load and unload passengers and self in and out of the boat in a safe manner

Demonstrate <i>awareness</i> of and <i>ability</i> to manage objective hazards (i.e., strainers, foot entrapment)	
Demonstrate <i>awareness</i> of subjective hazards (i.e., human factors and perceived risk)	
Demonstrate accurate self-perception of all personal skills and abilities presented in this skills assessment sheet. (i.e., does not display overconfidence or underconfidence that could put self and/or group at risk)	
Demonstrate <i>awareness</i> of group organization and communication while on the river	
Scout rapids within maximum course venue and assess all of the following: Objective Hazards • Various lines to navigate rapid • Potential consequences if lines are missed • Options for setting safety and swimmers	
Demonstrate an ability to choose and execute a plan to run Class III/IV rapids with confidence and control

Demonstrate knowledge of trip planning and environmental considerations. (i.e., weather, water level, water temps, etc.)
